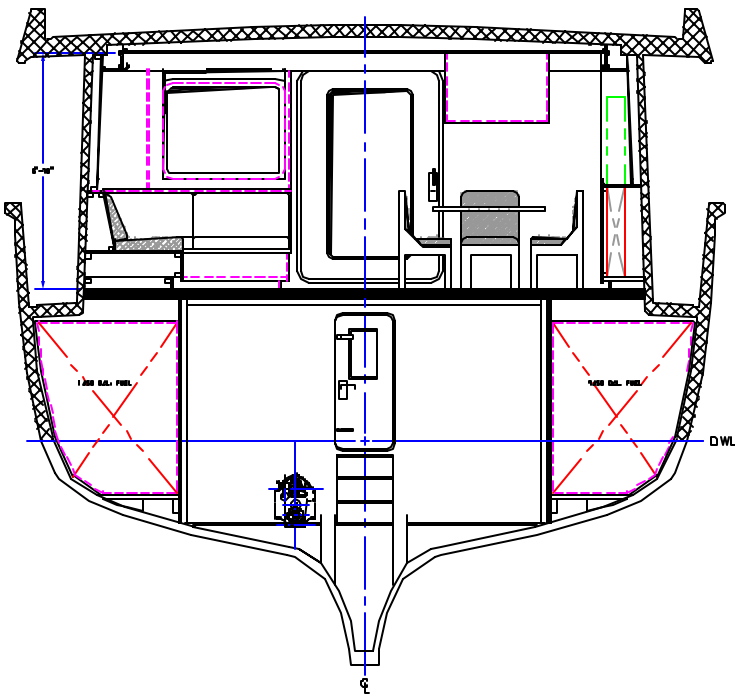
SECTION @ STATION 2.75 LOOKING AFT

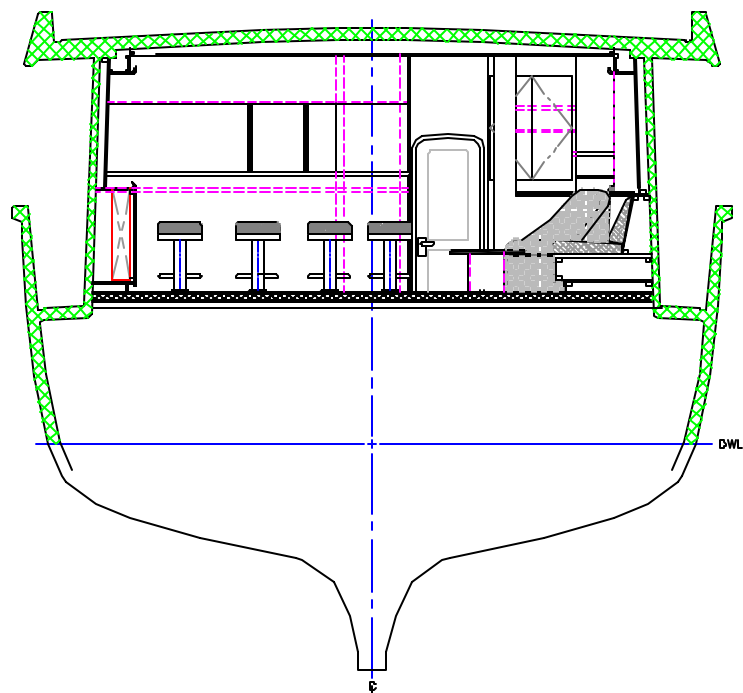
SECTION @ STATION 1 LOOKING AFT

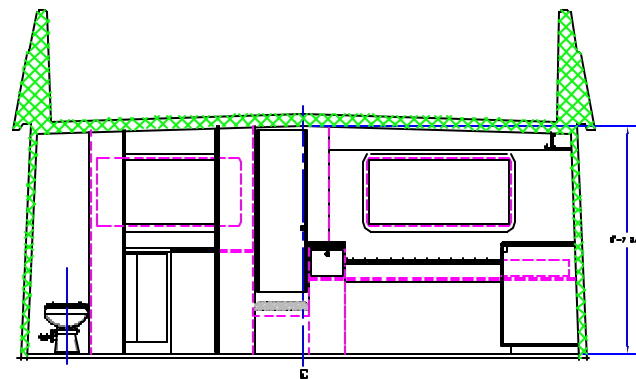
STATION 5 LOOKING AFT

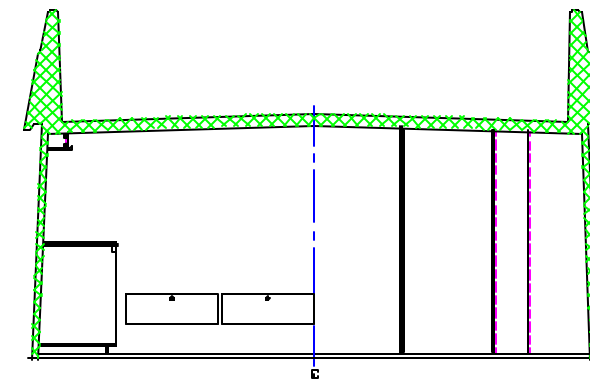
STATION 5 LOOKING FWD
